G.O.Rt.No.875, G.A(I&PR) Dept., dt.19.04.2016

In the reference read above, Government have constituted a Committee to work out the modalities of Single Window clearance for shooting permissions in Telangana State for finalization of categories of locations and fees to be charged by each Department and the mechanism to ensure that Single Window permissions are honored by the concerned departments, so as to encourage film / TV shootings and enable the film/TV producers to save time to get permission for shooting. The Committee held a detailed meeting on 19.8.2016 and made its recommendations.

2. Government after careful examination of the recommendations of the Committee have decided to implement the Single Window Shooting Permissions in the State with the following categorization of shooting locations:

Categorization of shooting locations:

- i) Green Zone - permission without timings and day of the week restriction
- ii) Yellow Zone - Permission with timings and day of the week restriction
- iii) Red Zone -No permission.

3. Government further order that Online Shooting permissions should be given by the Departments through Computerised System (of the Film Development Corporation) within seven days. After seven days, the permission will be deemed to have been given. The FDC should immediately take up preparation for online software in this regard. The FDC should design an online application form in which the Film Producer would give all the details such as precise location, date, exact time, number of persons involved in the shooting and number of vehicles used to ensure seamless conduct of shootings.

4. The Commissioner, Information & Public Relations Department/ Managing Director, Telangana State Film Development Corporation Limited, Hyderabad is instructed to have a meeting with the Film Producers' Associations to list out conditions to ensure that the film shooting crew stick to the exact time and date and damages to monuments and public buildings are avoided.

5. Government order that all the Departments list out the locations, categorize the same into the three categories, list out restrictions with respect to time and day of the week, conditions, fees to be charged and caution deposit to be kept to take care of the damages/after shooting restoration. The fees and caution deposit will be collected by the FDC. The caution deposit will be refunded duly deducting damages/ restoration repair charges. A part of the fees collected will be spent by FDC for the maintenance of the location.

6. Government further order that the amount collected as fees for permissions in various locations of various Departments shall be spent only on those locations of the respective Departments. The removal of garbage after shooting shall be the responsibility of the shooting crew otherwise the Caution Deposit will be charged for the purpose with fine. The concerned Department will recommend for charges (damages/fines etc.,) to be collected out of the caution deposit within 7 days from the date of shooting otherwise the full caution deposit shall be refunded by FDC.

7. Each department shall nominate Nodal Officer with contact details for operating the online system for giving requisite permissions within 7 days, as well as, liaising with the Telangana State Film Development Corporation and film shooting crew.

8. All the concerned Departments of Secretariat and their Heads of Departments are directed to follow the above instructions scrupulously.

9. The Managing Director, Telangana State Film Development Corporation Limited, Hyderabad shall take necessary action accordingly.
