ORDER:

In view of the circumstances reported by the Managing Director, Telangana State Film Development Corporation, Hyderabad in the reference 3rd read above, has informed that the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India has communicated reforms under State Reform Action Plan (SRAP)-2020. It was suggested that under Ease of Doing Business (EoDB), Permission for Movie Shooting should be provided only through an online system, to ensure that there is no physical touch point for the activities such as application submission, payment, tracking and monitoring of the application. The user shall be able to download the final approved certificate through their user login. Information related to procedure, fees, documents, timelines, link for third party verification along with department dashboard shall also be available in the Telangana State Film Development Corporation https://tsfilm.telangana.gov.in

- Government after careful examination of the matter, hereby decide to mandate the applications submission only through online portal, i.e. https://tsfilm.telangana.gov.in. OR https://ipass.telangana.gov.in.(Single window) and authorized the Telangana State Film Development Corporation (TSFDC) to act as a nodal agency to issue the movie shooting permissions in the locations controlled by the following departments:

 - d. Hyderabad Metropolitan Development Authority
