

Department Terms
<b>Forest Department</b>
<b>Terms and Condition</b>
No film shooting shall be permitted during the night hours, between sunset and sunrise.
Film shooting shall be conducted against the existing natural background/landscape only. No erection of sets or any other type of construction whether temporary or permanent will be permitted.
No cooking of food or littering of area will be permitted. Use of disposable plastics and polythene is strictly prohibited. No damage should be done to the flora and fauna at the shooting site including any ground vegetation or grass.
The area used by film shooting should be cleaned and restored back to normal after completion of shooting by the film shooting crew.
The film shooting crew shall not cause any damage to the flora, fauna, water bodies and ecosystem in the forest areas.
Only bare minimum number of vehicles as permitted by District Forest Officer/Forest Divisional Officer concerned will be allowed inside Reserve Forests and the vehicles will have to be park at the designated place.
The peace and tranquillity of the area shall not be disturbed with use of generators, music systems, making loud noise or vehicles hooking.
Only the crew and persons directly connected with film shooting shall be permitted entry. It will be the responsibility of the applicant to keep away onlookers/spectators. Number of persons to be permitted shall be decided by the District Forest Officer concerned.
Shooting team should invariably inform the District Forest Officer in-charge of the areas of shooting at least 3 days in advance.
The Forest Department shall not be responsible for any accidents/incidents during film shooting in the forest areas.
The Production Company should arrange sufficient water tankers & Fire safety equipment's at the site to avoid Fire incidents.
The film shooting should be done only in the area shown by the District Forest Officer.
The company should acknowledge the co-operation to the Government of Telangana while exhibiting the film.
<b>Greater Hyderabad Municipal Corporation (GHMC)</b>
<b>Terms and Condition</b>
The party shall not put up any extra structure or setting during the course of the film shooting and they should make self arrangement of the electricity.
Only the film shooting equipment's are permitted to move in the premises granted.
It is the responsibility of the party to get adequate traffic control arrangement made, as well as to take the other protective measures in the premises permitted, before, during and after the film shooting.
The structure and other installation of the premises should not be damaged. The damage amount will be recovered from the caution deposit by way of adjustment.
The company should acknowledge the co-operation to the Government of Telangana while exhibiting the film.

<b>Hyderabad Metropolitan Development Authority (HMDA)</b>
<b>Terms and Condition</b>
If the shooting session exceeds (1 hour) in succession, an extra amount for (4) hours will be charged.
The necessary permissions from Police (Law & Order) and traffic shall be obtained before the commencement shooting.
The agency should keep this security personnel to avoid the traffic problem etc.
The permission accorded shall be withdrawn at any time without assigning any reason
The agency should take appropriate steps to protect the environment and should not cause any damage to the infrastructure at the site.
In case of cancellation of shooting by the applicant the entire shooting charges will be forfeited.
Postponement is permitted twice only and with a penalty of Rs.2,000/- each time subject to the availability of dates, which will be recovered from the Security Deposit. The postponement is not permitted beyond a period of two months.
The said activity should not cause any disturbance to the visitors and road users, etc.
The HMDA/BPP shall not take any responsibility for any injury/accident/death of any person and the applicant who has taken permission for film shooting should bear all liabilities as per rules in force.
The applicant should visit the area in advance and make a recce to acquaint himself to prevent all possible accidents at the site.
The company should acknowledge the co-operation to the Government of Telangana while exhibiting the film.
